

## Registration



At this stage of your launch sequence, you'll focus on three essential steps: establishing your business entity, designing your business model, and preparing your RIA registration

#### Complete Initial Registration (IR) Questionnaire

#### Sign up for IR in the XYPN Portal

Once the above steps have been completed, the Compliance team will reach out to you to begin the registration process (Yay!)

#### Pay IR Fee and sign contract

#### Join the XYPN Compliance IR Drop-In

#### **Submit Your ADV**

#### HOLDING PATTERN

Once you submit your ADV, you enter an awkward holding pattern. You can't advertise your firm yet, but there's lots to do, so dive straight into the next section of your launch sequence.

Get started on all the things you'll need to do to take your firm live, but make sure it stays hidden until your ADV is approved. Regulators will check to make sure you aren't advertising your firm on your website, social media, or other channels.
